NOTIFICATION

This Notification is issued in continuation of the earlier Notification bearing No.KSAT/RPS/CB/35/2020 dated 15.05.2020.

The Central Government has extended lockdown period upto 31.05.2020 subject to certain restrictions. As per the Notification bearing No.KSAT/RPS/CB/35/2020 dated 15.05.2020, ordered for resumption of judicial work in so far as urgent Applications, subject to following certain norms to contain the spread of COVID-19. Taking note of the Central Government extending lockdown up to 31.05.2020, the Registry is directed to list all kinds of Applications (pending and fresh) **ONLY** when urgent orders are sought for, from 19.05.2020 to 22.05.2020 before **Court Hall-II** and from 26.05.2020 to 29.05.2020 before **Court Hall-III**.

Likewise, Benches at Belagavi and Kalaburagi will list Applications (pending and fresh) **ONLY** when urgent orders are sought for.

The Office of Principal Bench and Benches at Belagavi and Kalaburagi will function from 10.00 a.m. to 2.00 p.m.

It is made clear that no Application shall be listed for final hearing during the current month.

The above Notification shall come into force with immediate effect and the same shall be in force till **30.05.2020**.
