bearing No.KSAT/BB/DB/2/2020 - Reg.

Whereas, by Notification bearing No.KSAT/RPS/CB/35/2020 dated 15.05.2020, ordered for resumption of judicial work with effect from 18.05.2020 subject to following certain norms, so as to arrest the spread of COVID-19.

Whereas, on 17.05.2020, the Central Government extended lockdown for a further period of two weeks till 31.05.2020 with certain relaxation and with liberty to the State Governments to take further course of action with regard to further relaxation, on the basis of ground realities. Therefore, on 18.05.2020, Karnataka State Administrative Tribunal issued a Notification bearing No.KSAT/RPS/CB/37/2020, directing the Registry to list all kinds of Applications where urgent orders are sought for in pending and fresh matters, from 19.05.2020 to 22.05.2020 before Court Hall-II and from 26.05.2020 to 29.05.2020 before Court Hall-III of the Principal Bench and that Office would work from 10.00 a.m. to 2.00 p.m.

Whereas, on 19.05.2020, the State Government have extended lockdown period upto 31.05.2020, but granted permission for operating the State transport, public transport and private transport subject to certain conditions and also directed all Government servants to report for duty.

In view of the above, the Notification dated 17.3.2020 bearing No.KSAT/BB/DB/2/2020 is revoked with immediate effect and thereby all the three Benches (viz., CH-I, II and III) of the Principal Bench will work according to the roster Notification bearing No.KSAT/BB/DB/2/2020 dated 17.03.2020.

It is made clear that from today onwards, the Office of Principal Bench and Benches at Belagavi and Kalaburagi will work full day.
