Whereas, as per Notification dated 10.11.2020, applications were called for recruitment of 11 posts of Dalayaths in K.S.A.T., including Residual Parent Cadre as well as Local Cadre. Further, after conducting interview to all the candidates on 25.11.2020 a Provisional Selection List of only ten (10) candidates to the post of Dalayaths was published (Since, no application has been received from the Category of Scheduled Caste Ex-Servicemen Quota) calling for objections, if any, from the affected candidates within 07 days from 25.11.2020, by muddam or through email.id [registrar.kat@gmail.com](mailto:registrar.kat@gmail.com). Vide this office Notification dated 25.11.2020 referred to at (1) above.

Whereas, in response to the above Notification dated: 25.11.2020, the seven (7) candidates named (1) Sri Ananda Bellikatti, (2) Sri Shivanandaradhya, (3) Sri Hanumanthappa.K., (4) Sri Shekar Somu, (5) Sri Raghavendra, (6) Sri Hiresh.R. and Sri Manjunath.M.K., have filed their objections to the above said Provisional Selection List. After having gone through their objections, the Hon'ble Appointing Authority has rejected the same has having no merits for consideration.

Further, objections filed by persons other than the candidates have also been rejected on the ground that they have no 'Locus Standi' to question the same, since they have neither filed applications nor attended/appeared for interview.
