II. The Tender-cum-Auction sale shall be subject to the following terms & condition

A. Terms and conditions for "Tender"

1. The persons who are interested/desirous to offer their tenders shall submit tenders in a sealed cover to the Assistant Registrar, Karnataka State Administrative Tribunal, Kalaburagi

Bench, Kalaburagi, No.1-29-24/GF, KHB Colony, Kalaburagi-585102 on or before 04.8.2022 by 4.00 P.M.

2. Tenders should be submitted strictly in a sealed cover superscribed as "Tender for disposal of Two-Wheeler Suzuki Access-125 bearing No. KA-03-G-1223" belongs to Karnataka State Administrative Tribunal, Kalaburagi Bench, Kalaburagi. The covers, without seal, and without the above details will not be accepted.
3. The tenderers may inspect the Two-Wheeler which is in the premises of the Karnataka State Administrative Tribunal, Kalaburagi Bench, Kalaburagi (Basement) No.1-29-24/GF, KHB Colony, Kalaburagi-585 102 during office working hours between 11.00 AM and 4.00 PM on all working days except General Holidays and Saturdays before the last date and time fixed for receipt of tenders mentioned above.
4. The sealed tenders will be opened by the Assistant Registrar, Karnataka State Administrative Tribunal, Kalaburagi Bench, Kalaburagi, in the presence of tenderers and bidders immediately after auction is over.

B-TERMS AND CONDITIONS FOR 'AUCTION'

- (1) The Auction of Two-Wheeler shall take place at 11.00 AM on 06.08.2022 (Saturday) in the premises of the Karnataka State Administrative Tribunal, Kalaburagi Bench, Kalaburagi No.1-29-24/GF, KHB Colony, Kalaburagi-585 102.

- (2) The intending bidders may inspect the Two-Wheeler during Office working hours between 11-00 AM. And 4-00 PM on all working days except on general holidays and Saturdays.
- (3) The tenderers shall also be entitled to bid at the auction.
- (4) On the day of auction, the Officer conducting the auction sale, shall call for bids at the time and place specified, i.e., premises of Karnataka State Administrative Tribunal, Kalaburagi Bench, Kalaburagi No.1-29-24/GF, KHB Colony, Kalaburagi-585 102.
- (5) Persons participating in the auction shall pay Earnest Money Deposit (EMD) Rs. 5, 000/- (Rupees Five Thousand only) in the form of Demand draft drawn in the name of Registrar, KSAT., Bengaluru and Demand draft shall be furnished before the auction. Deposit amount will be returned to the unsuccessful bidder on the same day.

C-GENERAL TERMS & CONDITIONS

- (1) The Two-wheeler Suzuki Access will be disposed of on 'As is where is basis'. No correspondence in this regard will entertained.
- (2) Tenderers shall also be entitled to bid at the auction.
- (3) The Officers conducting the auction sale, may reject any offer or bid, in their opinion, if it is not satisfactory.

- (4) The Successful bidder/Tenderer shall Deposit 25% of the amount on the spot. On receipt of the confirmation of the bid/offer from the Registrar of KSAT., Principal Bench at Bengaluru, the bidder/tenderer will be informed to pay the balance amount which shall be paid within Seven (7) days from the date of intimation to pay the said amount. If the bidder/tenderer fails to pay the balance amount within the time stipulated, 25% amount paid by him shall be forfeited to Government and the Two-Wheeler will become the property of Karnataka State Administrative Tribunal, Kalaburagi Bench, Kalaburagi and Karnataka State Administrative Tribunal, Kalaburagi Bench, will have the right to dispose of the Two-Wheeler in any manner it deems fit, without prior notice.
- (5) If the auction-tender is not accepted by the Government the amount deposited will be returned by cancelling the process of auction-cum-tender.
- (6) The sale shall not be complete until the same is confirmed by the Government of Karnataka.
- (7) TAXES: CGST and SGST as per the prevailing tariff shall be applicable.
- (8) PAYMENT ON DELIVERY: All taxes and duties shall be extra. The balance payment together with taxes applicable at the time of payment for taking delivery of the Two-Wheeler shall be made to the Registrar, Karnataka State Administrative Tribunal, Bengaluru, and obtain the delivery order for taking delivery of the Two-Wheeler.

- (8). The successful auctioner /tenderer shall be responsible for payment of all expenses involved for transfer of vehicle to his name.
- (9) DELIVERY OF COPIES OF DOCUMENTS: Form No.29 & 30 of the Motor Vehicle Act.1986, will not be issued by this Office. The successful bidder/ auctioneer has to bring form No.29 & 30 along with them. Additional copies of Challan/Sale order /Delivery Order, if required by them to comply with check post formalities. The same may be arranged by the successful bidder/auctioner himself by taking xerox copies.
- (10) DELAYED DELIVERIES DUE TO CIRCUMSTANCES BEYOND THE CONTROL OF KARNATAKA STATE ADMINISTRATIVE TRIBUNAL : The Karnataka State Administrative Tribunal, Kalaburagi Bench, Kalaburagi, will not, in any way, be responsible for failure to deliver the Two-Wheeler if due to causes beyond its control, such as strike, lock-out, cessation of labour shortened hours, or other causes, or other contingency whatsoever, the buyer shall not be entitled to cancel the contract and the period of delivery shall be proportionately extended accordingly.
- (11) DOUBTS COURTS/DIFFERENCES/DISPUTES: In the event of any dispute in connection with the Tender-cum-auction sale at the time of Tender of auction, the decision of the

Karnataka State Administrative Tribunal, Bengaluru shall be final and binding on the parties to the auction sale. Further, in respect of any such dispute, doubts, differences of opinion, arising at the time of payment/ delivery, the tenderer/bidder shall agree and abide by any of the decision of the Registrar, Karnataka State Administrative Tribunal, Bengaluru.

- (12) LEGAL PROCEEDINGS: In the event of any dispute in connection with this auction such disputes shall be decided by the Courts at Kalaburagi, and no other Court shall have jurisdiction.
